I. General

A. Call to Order – Nathan Pullen, Board Chair
 The budget meeting was called to order at 5:03 p.m. by Nathen Pullen.

A. Chief Academic Officer Report

Dawn Woods provided an overview of the budget approval process and shared GLAAZ updates.

- State of Arizona Charter School Annual Budget Proposed
 - She and Leslie Shultz Crist went through the budget line by line with Al Charlesworth from NEXFaze. She explained the revenue from grants, tax credit, teachers' salaries and expenditures. The enrollment used for the budget is 118 and this is also the number that GLAAZ ADM was at consistently during SY 2020. Dawn Woods shared that GLAAZ will receive no less than 100% of the funding received during the 2020 school year due to CARES funding. Leslie Shultz-Crist explained the difference in the amount spent on special education compared to last year's expenditures.
- The Special Education teacher will be returning.
- The proposed opening process based on the Governor's new Executive Order. The school will open on August 3, 2020 with distance learning for all students. The day

- schools can open for in person teaching will be on August 17, 2020. Dawn is to send the Wish List to all School Board members top of the list are Clorox wipes.
- The school has received 80 of the 120 Chromebooks ordered. This is great news as they were originally back ordered and not expected until November 2020.
